1. Eligibility

You will be an **Eligible Customer** where:

- 1.1 As at 1 November 2022 you do not hold and are not insured under, nor have you in the 2 months prior to 1 November 2022 held or been insured under, a private health insurance policy issued by AIA Health.
- 1.2 You purchase a private health insurance policy issued by AIA Health that commences between 1 November 2022 and 15 December 2022 (Eligible Policy).
- 1.3 You have not utilised any other discount or promotion issued or provided by AIA Health within the last 12 months.

2. Offer – Bronze, Bronze Plus, Silver and Silver Plus combined products

The following offer applies to Eligible Customers only in an Eligible Policy:

- 2.1 You will be entitled to receive one (1) Garmin Venu Sq watch (Shadow Grey/Slate) in Year 1 plus up to 2 weeks

of premium refund and up to 3 weeks of premium refunds in Year 2 on your Eligible Policy.
