



Lost Policy Declaration For Lost/Destroyed Policies

Replacing your policy document:

- 1 Where an original policy document is lost or destroyed, AIA Australia may only issue a Replacement Policy document in accordance with the requirements of the *Life Insurance Act 1995 (Cth)* (Act).
- 2 When AIA Australia issues a Replacement Policy document, the original policy document becomes void.
- 3 Before AIA Australia can issue a Replacement Policy document, AIA Australia may be required to provide ten days notice of its intention to do so in a newspaper circulating in the State in which the Policy Owner resides (a statutory requirement in some circumstances).
- 4 AIA Australia can charge Policy Owners a fee to cover the cost of replacing a lost policy document, including the costs of advertising the loss (a statutory requirement in some circumstances).
